Part A: Pupil premium strategy plan

Statement of intent

At Hanwell Fields Community School we firmly believe that it is our responsibility to find 'the best in everyone'. We understand that some of our pupils face additional challenges and we look to use the Pupil Premium Funding to remove the barriers that stand in their way to ensure there is equity in what all of our pupils can and do achieve.

We know that the term 'disadvantaged' encompasses groups of pupils beyond those who are eligible for Free School Meals and we apply our working practices accordingly.

High quality teaching is at the heart of what we do. We know that this is proven to be the best way to tackle the disadvantaged deficit and improve the learning of all pupils. We have a clear understanding of how we believe lessons should be taught and we provide a focussed, researched based CPD offer for all staff to ensure this is achieved. We use diagnostic data analysis to identify where pupils require support and we use research, best practice and our experience to provide this in a targeted manner.

We believe staff and pupil relationships are key to pupil wellbeing, attendance and academic performance. We therefore use research based approaches to promote positive, restorative, trauma informed, predictable interactions between staff and pupils. We also have a range of nurture, welfare and inclusion resources available to our most vulnerable pupils and families.

Overall we:

- Adopt a whole school approach, where staff/pupils' relationships are at the core of what we do.
- We act early to address pupils educational and social disadvantage at the earliest opportunity.
- We use research and rigorous diagnostic assessment, not assumptions, to identify our pupils' challenges and carefully select a narrow range of activities to address these.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Early language: 2023 GLD data clearly demonstrated that Communication and Language was a barrier to a higher proportion of our pupils achieving GLD by the end of EYFS as Communication and Language elements thread throughout all areas of learning and development. Out of the 35% of pupils who did not achieve GLD, 11 children (18%) did not achieve Early-Learning Goals in Speaking, with 13 children (22%) not achieving an Early-Learning goal in Listening and Attention. In September 2023 Baseline WellComm assessments in Nursery and Reception 23/24 cohorts underlined this, with only 19% at age-related expectation within the Nursery cohort, and 49% at age-related expectation at the start of their Reception year with us.
2	Reading: Phonics (Year 1 2023) and Reading (KS2 SATs 2023) highlights the gap between outcomes of Pupil Premium vs Non-Pupil Premium. Pupil Survey outcomes also highlighted the low uptake in reading at home for pleasure.
3	Attendance: our overall attendance in 2022/23 was risen to 94.7%, above the national average, but below the national target of 95% and the schools' own target of 96%. Our Pupil Premium attendance in 2022/23 was 93.3%, a gap of -1.3% to Non-PP at 94.6%.
4	Engagement: to discover the best in everyone we must ensure all pupils are fully engaged in their learning, with lessons adapted to the needs of individuals and/or groups and no learning disrupted by low level behaviour. We must also ensure that our disadvantaged pupils do not suffer an educational deficit by not having the pre-requisite knowledge, skills or experiences to access a lesson or topic. Stakeholder voice and monitoring of learning indicates that a proportion of pupils are not fully engaged in their learning and this can have an impact on outcomes or behaviour.
5	Personal development: we must provide equity in our curriculum and extra-curricular offer to ensure all pupils have the same opportunities, responsibilities and experiences and leave our school with the same cultural capital as their peers. In order to identify impact we must first create a baseline of PP vs non-PP participation and demonstrate a closing of this gap.

Part B: Review of the previous academic year (2022/23)

Outcomes for disadvantaged pupils

We have analysed the performance of our school's disadvantaged pupils during the previous academic year, drawing on national assessment data and our own internal summative and formative assessments.

To help us gauge the performance of our disadvantaged pupils we compared their results to those for disadvantaged and non-disadvantaged pupils at national and local level and to results achieved by our non-disadvantaged pupils.

The data demonstrates that Pupils are performing above national averages (in comparison with United Learning data) in Years 1, 4 and 6. The outcomes are marginally below in Year 2 and 3, but a larger gap exists in Year 5. There is a gap, however, between PP and non-PP in every year group. In 2024/25 this will be tracked closely to establish if the gap is closing or closed.

We have also drawn on school data and observations to assess wider issues impacting disadvantaged pupils' performance, including attendance, behaviour and wellbeing.

The data demonstrated that PP attendance is below that of non-PP but is above the national average for all pupils. Behaviour data, internal and external, shows that there is a marginal gap between PP and non-PP. The number of PP pupils under CP/CinN/TAF is significantly higher than the number of non-PP.

Based on all the information above, the performance of our disadvantaged pupils *did not meet* expectations, but we are at present *on course* to achieve the outcomes we set out to achieve by 2024/25, as stated in the Intended Outcomes section above.

Our evaluation of the approaches delivered last academic year is here:

Challenge 1 - Early Language

GLD of 77% at the end of Reception 2024, which is above the national average.

There was a low number of PP eligible children, who both had additional needs, which makes data comparison difficult.

Fluency data was collected across the school, which builds on early language acquisition, and this data confirmed that PP pupils made accelerated progress against non-PP in all years except Y4. PP pupils in Year 2 and 5 exceeded non-PP in terms of attainment.

Challenge 2 – Reading

The attainment data at the start of this section highlights that there remains an attainment gap between PP and non-PP. As a school, we identified that language acquisition and resulting reading fluency were a barrier to Reading attainment, we are therefore encouraged that PP pupil reading fluency is closing the gap on non-PP and we expect to see this reflected in future Reading data.

Challenge 3 – Attendance

23/24 - Reception - Year 6 = 95.1%

23/24 - NON PP: 95.7%

23/24 - PP - 93.0%

There is a 2.7% gap between PP and non-PP attendance. This gap has narrowed since 2022/23 and is also reflected in PA data. We continue to work hard to close this gap, through intense monitoring and building positive relationships with families, but we are encouraged that 93% PP attendance is above the PP national average and close to the overall national average.

Challenge 4 – Engagement

Behaviour data confirms that there is no concerns regarding PP pupils behaviour in school. Recorded serious breaches are lower for PP pupils. Pupil voice is also positive. Attendance remains the barrier.

Challenge 5 – Personal Development

All PP pupils have been offered extra-curricular clubs free of charge. Despite this their attendance at clubs in and out of school remains below non-PP. To address this we will be offering more lunchtime clubs and providing personal invites to after-school clubs, exploring barriers to attendance in the process.

All PP pupils attended school trips and participated in competitive sports fixtures in school and against other schools.

Additional activity

Our pupil premium strategy will be supplemented by additional activity that is not being funded by pupil premium or recovery premium. That will include:

- embedding more effective practice around feedback. <u>EEF evidence on feedback</u> demonstrates this has significant benefits for pupils, particularly disadvantaged pupils.
- utilising a <u>DfE grant to train a senior mental health lead</u>. The training we have selected will focus on the training needs identified through the online tool: to develop our understanding of our pupils' needs, give pupils a voice in how we address wellbeing, and support more effective collaboration with parents.
- offering a wide range of high-quality extracurricular activities to boost wellbeing, behaviour, attendance, and aspiration. Activities
 will focus on building life skills such as confidence, resilience, and socialising. Disadvantaged pupils will be encouraged and
 supported to participate.

Planning, implementation, and evaluation

In planning our new pupil premium strategy, we evaluated why activity undertaken in previous years had not had the degree of impact that we had expected. We also commissioned a pupil premium review to get an external perspective.

We triangulated evidence from multiple sources of data including assessments, engagement in class book scrutiny, conversations with parents, students and teachers in order to identify the challenges faced by disadvantaged pupils. We also contacted schools local to us with high-performing disadvantaged pupils to learn from their approach.

We looked at several reports, studies and research papers about effective use of pupil premium, the impact of disadvantage on education outcomes and how to address challenges to learning presented by socio-economic disadvantage. We also looked at studies about the impact of the pandemic on disadvantaged pupils.

We used the <u>EEF's implementation guidance</u> to help us develop our strategy, particularly the 'explore' phase to help us diagnose specific pupil needs and work out which activities and approaches are likely to work in our school. We will continue to use it through the implementation of activities.

We have put a robust evaluation framework in place for the duration of our three-year approach and will adjust our plan over time to secure better outcomes for pupils.
